

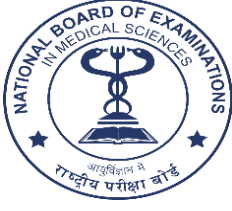

Subject: Revised cut-off scores of NEET-MDS 2023 after lowering of qualifying percentiles.

1. The result of NEET-MDS 2023 was declared on 10th March, 2023. In accordance with the Ministry of Health & Family Welfare, Govt. of India letter No. V. 12025/14/2023-DE dated 21st September 2023, the minimum qualifying percentiles have been lowered [in pursuance of the 2nd Proviso in clause 7 (1) of DCI's Master of Dental Surgery Course (1st Amendment) Regulations, 2018] for NEET-MDS 2023 as follows:


