Heard on I.A.No. 6962/2023, an application for issuance of ad-interim writ.

Earlier, this Court vide order dated 15.09.2023 had issued notice to the respondents and by way of interim relief, it was directed that the petitioner herein be permitted to appear in the MOP UP round subject to final outcome of this petition.

Learned counsel for the petitioner submitted that the order dated 15.09.2023 modified in as much as in identical case filed by the candidate belonging to the OBC category, a seat has been allotted in the Gajra Raja Medical UR GS category in adherence to the interim order passed by the Principal Bench of this Court in W.P.No. 22809/2023. Despite having secured more marks than the persons having been allotted seats including the petitioner in W.P.No. 22809/2023, the petitioner is subjected to hostile discrimination. In such a situation, respondents be directed to allot a seat in the medical college for MBBS course in this case as well.

On the other hand, learned counsel for the respondent/State opposed the prayer and submitted that there is already an interim order in favour of the petitioner, therefore, no modification is required and the application deserves to be dismissed.

Taking into consideration the fact that the matter is to be heard finally,

therefore, in the interest of justice, it is directed that the order dated 15.09.2023 is modified to the extent that one seat be kept vacant till the next date of hearing (if not already filled).

With the aforesaid modification, I.A.No. 6962/2023 stands allowed and disposed of.
