Whereas the above bounden*.....is nominated to a Government stipend and WHEREAS Government have agreed to pay the above bounden*.....

NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT :-

IN THE EVENT OF THE above bounden*.....

- (a) Not conforming to instructions regarding training of studies conveyed to her by an authorized agent of Government or
- (b) being reported on adversely during the period of training in respect of her studies or conduct; or.
- (c) failing to pass an examination or complete the course of training without reasonable excuse (of which the Government shall be the deciding authority) : or,
- (d) failing or refusing to serve the government, if called upon to do so on completion of the training in any post under Community Development Programme or elsewhere considered suitable by Government (Whose decision in this behalf shall be final) having due regard to the training obtained by her for a period of not less then three years from the date of the offer made by Government within Two Month from the date of her completion of the training. The bond will stand Null and valid if no job offered within said period of 2 months and candidate will be free from bond conditions.
- (e) being reported on adversely in respect of her work or conduct shall forthwith refund to the Government on demand all monies paid to her and all other expenses incurred on her account in connection with the said training or studies as a stipendiary as aforeside, failing which the same will be recovered from the candidate or surety a arrears of land revenue.

PROVIDED ALSO that upon her rendering service satisfactorily under Government under these presents the liability to refund shall be reduced proportionately according to the years of services actually renders i.e. to one-fourth for one complete year of service, to half for two complete years of service. Provided further that no exemption from refund will be allowed for periods of services which are not complete years.

AND upon her making such refund the above written obligation shall be void and of no effect, otherwise it shall be and remain in force and virtue.

PROVIDED ALWAYS THAT THE liability of..... the surety %..... hereunder shall not be impaired or discharged by reasons of time being granted or by variation of terms of training or service or by any fore bear act or omission of the Government or any person authorized by them (whether with or without the consent or knowledge of the said surety) nor shall it be necessary for the Government to sue or take any steps/proceedings against the said *..... before issuing or taking any steps or proceedings against the said surety for amounts due hereunder.

PROVIDED also that if any question or dispute shall arise as to the amount payable by her the decision of the Government shall be final and binding.
