Subject: Result of NEET-MDS 2024

- NEET-MDS 2024 was conducted on 18th March, 2024 for admission to various MDS Courses of 2024-25 admission session.
- The result of NEET-MDS 2024 indicating the score obtained by the candidates and their NEET-MDS 2024 Rank has been declared and can be seen at NBEMS websites https://natboard.edu.in/

- 3. **NEET-MDS 2024 Rank:** This is the overall merit position of the candidate amongst all the candidates who have appeared in the NEET-MDS 2024.
- 4. In accordance with the minimum qualifying/eligibility criteria for admission to MDS courses as mentioned in the Information Bulletin for NEET-MDS 2024, the cut-off scores for various categories are as follows:

Category	Minimum Qualifying/Eligibility Criteria	Cut-Off Scores (Out of 960)
General/EWS	50 th percentile	263
SC/ST/OBC (Including PwBD of SC/ST/OBC)	40 th percentile	230
General PwBD	45 th percentile	246

5. Each and every question in NEET-MDS 2024 was reviewed by the subject matter experts from the concerned specialty after the conduct of NEET-MDS 2024 to recheck for technical correctness of the questions as well as answer keys. As per inputs from the subject matter experts, one question was found to be technically incorrect in Question Paper of NEET-MDS 2024. Full marks have been awarded to all the candidates who appeared in the exam, irrespective of the fact whether this question has been attempted or not attempted by the candidates.

- 6. The merit position for All India 50% Quota seats shall be declared separately. The final merit list/category wise merit list for State Quota seats shall be generated by the States/UT as per their qualifying/eligibility criteria, applicable guidelines/Regulations & reservation policy.
- 7. Individual scorecard of the candidates who appeared NEET-MDS 2024 can be downloaded from the NEET-MDS website https://nbe.edu.in/ on/after 12th April 2024.
- 8. Candidature is purely provisional subject to fulfillment of eligibility criteria as mentioned in NEET-MDS 2024 Information Bulletin.
- 9. If at any stage, candidates are found to have resorted to use of any unfair means in the exam, such candidates shall be liable for penal action/action as deemed appropriate by NBEMS will be taken against the candidates. In the event of any such candidates being declared successful in the NEET-MDS 2024, the results/candidature of such candidates shall be cancelled and/or are deemed to be cancelled.
