Sub: Stoppage of admissions to the BDS course at Guru Gobind Singh College of Dental Sciences and Research Centre, Burhanpur, Madhya Pradesh for the AY 2025-26 - reg.

Sir,

I am directed to refer to the subject mentioned above and to say that based on the recommendations of DCI dated 04.12.2024 (copy enclosed), an opportunity was provided to the college to present its case/compliance report before the Hearing Committee on 18.02.2025. The Hearing Committee considered the submissions made by the College and after careful consideration agreed with the recommendations of DCI. Subsequently, this Ministry vide letter dated 05.03.2025 (copy enclosed) requested the State Govt of Madhya Pradesh to provide its comments on the recommendations of DCI.

2. The State Government submitted its comments vide letter dated 09.04.2025, which were at variance with the recommendations of the DCI. Accordingly, these comments were forwarded to the DCI for its comments/recommendations. The DCI, in response, submitted revised recommendations through letter dated 24.07.2025 (copy enclosed).

3. Considering the revised recommendations of DCI, the Central Government has decided to **stop admissions to the BDS course at Guru Gobind Singh College of Dental Sciences and Research Centre, Burhanpur, Madhya Pradesh for the AY 2025-26.**

4. Therefore, you are directed NOT to admit students in the BDS course for the academic year 2025-26.

5. Any admission made in violation of the above condition will be treated as irregular and action under the provisions of the Dentists Act, 1948 and Regulations made thereunder shall be taken.
